







# **RIPE** [NCC] and the ITU

- - Since 2002, the RIPE NCC has provided DNS operations for the e164.arpa zone (ENUM), based on instructions from IAB
- in Internet governance
  - Contributing to discussions on topics relevant to RIR "core business"
  - Participating in major meetings (including policy fora)
  - Following Study Group discussions, tracking relevant proposals

## Engagement with Study Group 20 on IoT


- An SG20 proposal on IPv6 addressing was brought to the RIPE community for comment (on the IPv6 WG mailing list and at RIPE 76)

- To what extent do Member States want to expand the ITU's remit in the Internet space?
